Such wastewater will consist of domestic sewage, i.e., waterborne human waste and waste from domestic activities such as bathing, washing, and food preparation. The Utility has reviewed the plans for this subdivision ("the Plans") and has estimated the wastewater flow projected by the Subdivision under fully built-out conditions ("the projected wastewater flow") to be 12,000 approximately gallons daily.

The Utility warrants that necessary arrangements have been made to supply the anticipated water flow for at least thirty years (30). The Utility covenants that it has or will have the capacity to provide the anticipated water flow, and that it will provide that water flow. The covenants will be in effect until thirty years (30) after the plat of the Subdivision has been recorded and the Subdivision's water distribution has been connected to the Utility's water supply system.


The Subdivider covenants that the wastewater collection system be constructed as shown in the Plans and as provided for through the plat approval process so that the residents of the lots of the Subdivision may receive wastewater treatment service from the Utility. Upon completion of the wastewater collection system and upon its approval and acceptance by the Utility, the Subdivider will convey all right and title to the wastewater collection system.

The above provisions notwithstanding, this Agreement shall no longer be in effect if the plat of the Subdivision is not approved by Maverick County and the City of Eagle Pass.

RESOLUTION NO. 2025-EPWWS-HWY 57

A RESOLUTION OF THE CITY OF EAGLE PASS WATER WORKS SYSTEM ("EPWWS") BOARD OF TRUSTEES SUPPORTING THE EXPANSION OF US 57 TO A 4 - LANE DIVIDED HIGHWAY TO INCLUDE THE PLANNING, DESIGN, CONSTRUCTION, OPERATIONS, AND MAINTENANCE OF A 4-LANE DIVIDED HIGHWAY INCLUDING PROVISIONS FOR THE EXPANSION OF THE BORDER PATROL STATION 11 MILES EAST OF EAGLE PASS; FINDING THAT THE MEETING AT WHICH THIS RESOLUTION IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW; PROVIDING A SEVERABILITY CLAUSE; AND ESTABLISHING AN EFFECTIVE DATE

Whereas, the City of Eagle Pass, Texas is a municipal corporation, home rule city and local government; and

Whereas, the City of Eagle Pass, Texas created and established a separate water and wastewater (also referred to as sewer) system pursuant to Article X, Section 10-4(d) of the Eagle Pass City Charter known as the City of Eagle Pass Water Works System ("EPWWS") for the use of the public to furnish water and wastewater service and to make and collect such charges and fees for such water and wastewater service as may be fixed by the City Council of the City of Eagle Pass, Texas; and

Whereas, EPWWS (a) is owned by the City of Eagle Pass, Texas; (b) is governed by a Board of Trustees; and (c) manages and operates (i) a water supply, treatment, storage, transmission and distribution system; and (ii) a wastewater collection, transmission, treatment and disposal system; and

Whereas, EPWWS further has the right to (a) construct additions, extensions, improvements, replacements and repairs to the (i) water supply, treatment, storage, transmission and distribution utility facilities; and (ii) wastewater collection, transmission, treatment and disposal utility facilities; and (b) obtain sufficient quantities of water from surface and/or groundwater sources to supply the potable water needs of the present and future customers of EPWWS; and

WHEREAS, in a SPECIAL JOINT WORKSHOP held on Wednesday, August 6, 2025 at 3:00 PM at the International Center for Trade, 3295 Bob Rogers Dr., Eagle Pass, Maverick County, Texas, the Board of Trustees of the City of Eagle Pass Water Works System, the Eagle Pass City Council, Maverick County Commissioners Court, the Eagle Pass Independent School District Board of Trustees, the Eagle Pass

Chamber of Commerce and the Hospital District met to discuss the expansion of US 57 to a 4-lane divided highway understanding that:

- 1. US 57, is experiencing an increase in traffic volumes including Commercial Motor Vehicles leading to ever increasing safety concerns.
- 2. Commercial Motor Vehicles represent over 20% of traffic along US 57 which is higher than the average on similar highways; however, over the 2017 2022 period, fatal crashes involving CMVs accounted for nearly one third of all fatalities.
- 3. US 57 is on the Texas Highway Freight Network and National Highway Freight Network and has been designated by TxDOT as a high priority corridor.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE CITY OF EAGLE PASS WATER WORKS SYSTEM:

Section 1. That it hereby supports the expansion of US 57 to a 4 - lane divided highway to include the planning, design, construction, operations, and maintenance of a 4-lane divided highway including provisions for the expansion of the Border Patrol station 11 miles East of Eagle Pass.

Section 2. It is officially found, determined and declared that the meeting at which this Resolution is adopted was open to the public, and that public notice of the time, place, and subject matter of the public business to be conducted at such meeting, including this Resolution, was given to all as required by the Texas Codes Annotated, as amended, Title 5, Chapter 551, Government Code.

Section 3. This Resolution becomes effective immediately upon its passage.




